# **Budget Overview for October, November, and December**

- The Board voted to move back the fiscal year to reflect 1 calendar year. The new fiscal year will now reflect January -December.
- A separate budget will be set for the remaining months that will include October, November, and December of 2022. The funding for this will come out of the Capital Reserve.

# A look ahead for January-December 2023 Budget

- The new board will have to set this budget. With our current President and Treasurer stepping down in December, the new key positions will need to set the budget, this is best practice.
- Both current President and Treasurer will work with the new positions to make sure there is a smooth transition.
- October, November, and December budgets will provide the groundwork for the new fiscal year budget and allow us to get a better understanding of the cost that will be associated with the gym usage. The excel document was provided with the projected cost for January- December. This will be uploaded on the Bella Housa Website.

#### Gym Usage

- The board goal is to get the gym opened by end of October.
- There will be 1 weekend both Saturday and Sunday to meet with residents to sign rules for access to HOA Gym, clubhouse, and a liability waiver. Access will then be given at this time.
- What is left for preparation
  - Lock installation
  - Gym rules need to be set
  - Trash Service needs to be started
  - o Activation of equipment, to include batteries and registration.

  - The request for nominations went out in August and we only had 1 for Vice President. Elections were not held because of this.
